General Overview of Adviser Academy

- 1. Apply at get accepted by the beginning of May.
- 2. Attendance at National Leadership Conference
 - Attend four meetings related to the tracks
 - Attend additional Adviser Professional Development Sessions
 - Attend different Recognition Sessions
- 3. Complete assignments related to the five tracks over the course of the school year
- 4. Graduates are recognized with a certificate of completion at the Adviser Recognition Session at the National Leadership Conference following the completion of all five tracks and submission of all assignments

General Overview of Adviser Academy

5 Tracks (twenty-five assignments)

- 1. Developing a Chapter Vision
- 2. Using Legislation to Change the Classroom
- 3. Leading at School
- 4. Remaining Relevant as a Chapter
- Participating at the State Level

- Assignments are completed throughout the school year.
- Final assignments for each track is a journal, detailing expectations & documenting progress.

- Others are activities to encourage you to go more indepthly into FCCLA and involve your chapter outside of the school at the community/state level


This revelation came to me at several times during my participation in the Academy beginning with our first assignment a personal plan for Work-Life Balance.

Step 1 - How balanced is your life?

Here is a simple tool, which you can use to assess your current level of balance. You will probably want to draw your own wheel and put your own labels on the spokes. If you would like to improve your life balance, start by doing the balance wheel exercise and then set yourself some goals to reduce the level of dissatisfaction.

After you have HONESTLY taken the time to complete a work life balance assessment or write a personal plan.

- Implement it
- Set some boundaries
- Make sure those involved know the boundaries
- FORGIVE YOURSELF when it doesn't work

Lesson One: You CAN'T do it all...seriously DON'T try!

FCCLA has a lot to offer don't try to conquer it all in the first or even your fifth year.

Advice from other advisers:

- "Start small get a group of kids excited about an activity and build from there."
- "Find joy in small accomplishments, time spent with your students is never wasted."
- "Don't try to do everything at once, it would be overwhelming."
- "Don't take on too much, start small and add a little more and more every year."
- "Choose a few things to focus on. You cannot possibly do it all especially when you are new."
- "Don't worry about all the things you see others doing, focus on what you can do and do it well."

Advice from other Advisers:

- "Sometimes you have to work to give up control. Let the kids or others do it."
- "Build a network within your school and community so you have adult support when it comes to projects, fundraisers, judges, sponsors, etc."
- "Get to know other advisers across the state, they are invaluable resources!"
- "I try to guide the kids but it is still up to them. I always say this is your organization so if you want it to happen then do it...officers set a personal and chapter goal...keep that in mind."
