

**NEBRASKA ASSOCIATION OF FCCLA
FCCLA SCHOLARSHIP AWARD POLICIES
FOR: Family and Consumer Sciences Education Major**

The purpose of this scholarship program shall be:

1. To develop interest in Family and Consumer Sciences Education.
2. To increase the number of secondary Family and Consumer Sciences teachers.
3. To increase the potential for additional FCCLA chapters.

I. Guidelines/Regulations

1. The Nebraska Association of FCCLA shall award one or more \$500 scholarships to outstanding FCCLA members planning to enroll in a four-year accredited college or university with a major in Family and Consumer Sciences Education. The number of scholarships awarded each year will be based upon the assets in the Nebraska FCCLA Program Support Fund.
2. The recipient must enroll in a college or university and begin using the scholarship within six months after graduation from high school. If enrollment does not take place within this time, the recipient will no longer be eligible for this award.
3. Alternate recipients:
 - a) Should the recipient forfeit the initial acceptance of the scholarship, the State Adviser shall contact an alternate candidate to receive the scholarship under the existing regulations. The applicant shall immediately notify the State Adviser in writing and decline the scholarship.
 - b) Should the applicant withdraw from college during or after the first year, the remainder of the award shall be available to a scholarship alternate for that particular year. The applicant shall immediately inform the State Adviser in writing of this change.
4. Upon written verification of the recipient's enrollment in a college or university, \$62.50 per semester will be disbursed to the college/university Registrar or Financial Officer to total \$125 annually. Proportionate sums may be paid for summer sessions, but the scholarship total may not exceed \$500. Such requests must be made in written form to the State Adviser who will make the final decision. The scholarship shall be used for tuition only.
5. The recipient must be enrolled as a full-time student at the accredited college/university of their choice. A minimum course load of 12 credit hours per semester must be carried to maintain eligibility.
6. Continuation of the scholarship over the four-year period is dependent upon the recipient maintaining a 3.0 GPA or higher each year.
7. At the end of each year, a confirmation notice will be sent to all scholarship recipients to verify the recipient's eligibility status. Upon receiving the applicant's acceptance notice for the ensuing semester, the next portion of the scholarship funds shall be disbursed to the college/university's Registrar or Financial Officer. This procedure will continue up to a total of eight semesters or as long as the recipient continues to meet the requirements.
8. The recipient(s) shall be announced before the annual FCCLA State Leadership Conference. The recipients do not have to be present to accept the award.

II. Qualifications

1. The applicant shall be a member of an affiliated chapter of the Nebraska Association of FCCLA and shall have been such a member for at least one membership year.
2. The applicant shall have actively participated in his/her own chapter.
3. The applicant shall have been enrolled in Family and Consumer Sciences classes for at least one year or the equivalent of one year.
4. The applicant shall be a senior in an accredited high school expecting to graduate at the end of the school year and shall have maintained an 85% cumulative average during high school. (3.4 on a 4.0 scale)
5. The applicant shall be planning to major in Family and Consumer Sciences Education (as preparation for teaching Family and Consumer Sciences courses at the middle/secondary school level) in an accredited four-year college or university offering a major in this area.
6. The applicant will be required to include the following supporting materials **with** their application:

- a) Recommendation by an officer of local chapter (must be sealed individually).
 - b) Recommendation by Family and Consumer Sciences teacher/chapter adviser (must be sealed individually). (Note: if this is the candidate's parent/guardian, it should be written by another teacher who can speak to the candidate's FCCLA participation.
 - c) Recommendation by a school administrator (must be sealed individually).
 - d) High school transcript.
7. The applicant's adviser should get all of the sealed information, application and transcript and submit on behalf of the applicant. (Note: If the applicant's adviser is the applicant's parent/guardian, this should be completed by another representative from the school.)
 8. Representatives of the District Advisory Committee and State Officer Team shall serve as the Scholarship Committee and shall name the recipient(s).
 9. The scholarship recipient shall keep the State Adviser informed regarding any changes in major, academic and enrollment status.

III. Rules For Applying

1. The applicant shall acquire a scholarship application online. All application and supporting materials must be **scanned as a single document attachment and emailed to the current Board of Directors Chair by February 1.** This information can be found in the current *Red Handbook*.
2. The applicant may choose any accredited four-year college or university that offers a major in Family and Consumer Sciences Education and qualified its graduates for a teaching certificate valid for teaching Family and Consumer Sciences courses. The applicant shall not transfer from his/her chosen school except to one meeting like qualifications.
3. Any FCCLA chapter member in good standing of the Nebraska Association of FCCLA who meets the stated qualifications, may apply regardless of financial standing.

IV. Special Consideration

1. In completing the application form, applicants are encouraged to reflect upon their personal FCCLA leadership and growth experiences, participation in STAR, achievements in Power of One, contributions to the community, and involvement in other state/national programs.
