Articles of Incorporation.



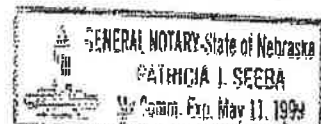
